A assessoria do Deputado Cristiano Araujo visitou as instalações do Centro e constatou que as condições de estrutura são precárias, oferecendo riscos aos alunos e professores.

As fotos em anexo mostram a precariedade da estrutura do CAS, a escola não possui forro no teto, os banheiros são utilizados como depósitos além da falta de azulejos, sanitários infantis, pias adaptadas as crianças.

A falta de segurança é visível, as janelas estão quebradas, materiais enferrujados, faltam iluminação, a cozinha utilizada por eles é improvisada, não tem bebedouro com água filtrada. Um dos graves problemas identificados é a fiação exposta em vários pontos, colocando em risco a segurança de alunos que além da deficiência auditiva possuem também deficiência visual.

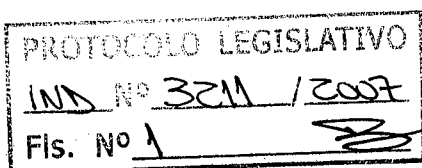
