A transferência do Centro de Apoio ao Surdo – CAS para as dependências da escola classe localizada na quadra 315 da Asa Sul, visa um melhor atendimento aos alunos.

A assessoria do Deputado Cristiano Araújo visitou as instalações do Centro e constatou que as condições de estrutura são precárias, oferecendo riscos aos alunos e professores.

As fotos em anexo mostram a precariedade da estrutura do CAS, a escola não possui forro no teto, os banheiros são utilizados como depósitos além da falta de azulejos, sanitários infantis, pias adaptadas as crianças.

A falta de segurança é visível, as janelas estão quebradas, materiais enferrujados, faltam iluminação, a cozinha utilizada por eles é improvisada, não tem bebedouro com água filtrada. Um dos graves problemas identificados é a fiação exposta em vários pontos, colocando em risco a segurança de alunos que alem da deficiência auditiva possuem também deficiência visual.

Em função dos problemas mostrados sugerimos que o Poder Executivo envide esforços para transferir o programa de apoio aos surdos que desenvolve um belíssimo trabalho para uma nova sede onde os professores tenham condições de exercer o melhor trabalho possível.

Dante do exposto, rogo aos Nobres Pares o apoio para aprovação desta indicação.
